**RESOLUTION #2020-5**

A RESOLUTION OF THE CITY OF STANLEY, CUSTER COUNTY, IDAHO TO SUBMIT FOR APPROVAL TO THE VOTERS OF THE CITY OF STANLEY ORDINANCE #56 D-6.

WHEREAS, the Stanley City Council have held a public hearing according to the law, and have approved Ordinance #56 D-6 for the collection of non-property taxes;

NOW THEREFORE, BE IT RESOLVED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STANLEY, CUSTER COUNTY, IDAHO:

That Ordinance #56 D-6 be sent to the voters of the City of Stanley for approval with the following ballot language:

**QUESTION:** Shall the City Council of the City of Stanley adopt Ordinance No. 56 D-6, which Ordinance shall extend the non-property general sales tax of two and one-half percent (2.5%) on all goods and services currently subject to Idaho State Sales tax for another 10 (ten) years? Option Tax revenues supplement the City General Fund for the support of planning improvements, operation and maintenance of the community building and recreation facilities, including Pioneer Park, Valley Creek Preserve, Central Idaho Dark Sky Reserve, emergency services, law enforcement, capital improvements and maintenance of roads and water systems, direct costs to collect and enforce tax, promotion for the city including community based organizations, special events, festivals, matching funds for grants to further the goals of the Stanley Comprehensive Plan, costs for planning, design, construction and maintenance of water and sewer systems and other infrastructure to support workforce housing, costs of planning, design, construction, maintenance and supervision of workforce housing built on city-owned property and centralized recycling program.

**YES**, The City Council shall approve Ordinance No. 56 D-6. (A “yes” vote will extend the existing 2.5% non-property tax on all goods and services currently subject to Idaho State Sales tax, from 2021 through 2031.)


**NO**, The City Council shall not approve Ordinance No. 56 D-6. [A “no” vote does not extend the non-property general sales tax for another 10 (ten) years and the tax will be rescinded.]

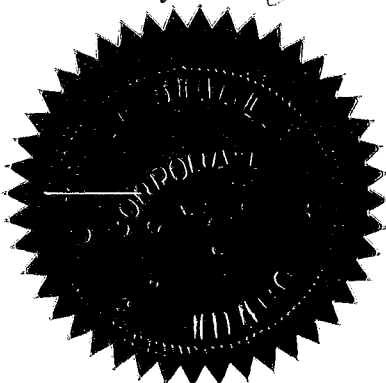
This Resolution shall be in full effect upon its adoption.
