

Compensation for Elected City Officials

AN ORDINANCE REPLACING TITLE 2, CHAPTERS 2.04 AND 2.06 OF THE STANLEY MUNICIPAL CODE, PROVIDING FOR MEETINGS AND COMPENSATION FOR ELECTED CITY OFFICIALS, AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STANLEY, IDAHO:

Section 2: Chapter 2.04 is hereby adopted:

CHAPTER 2.04

CITY COUNCIL

SECTION:

- 2.04.010: Regular Meetings
- 2.04.020: Special Meetings
- 2.04.030: Council Member's Compensation

2.04.010: **REGULAR MEETINGS:** Regular meetings of the city council shall be held each month at the Stanley Community Building Hall. The day of the week and time for regular meetings shall be established by Resolution of the city council.

2.04.020: **SPECIAL MEETINGS:** Special meetings may be called by the mayor or by three (3) members of the council and such special meetings shall be held at a place designated by the mayor.

2.04.030: **COUNCIL MEMBERS' COMPENSATION:**

- A. Commencing January 1, 2022, each member of the city council shall receive an annual salary in the sum of two thousand four hundred dollars (\$2,400), to be paid in monthly installments. Each city council member also shall receive Idaho Public Employee Retirement System of Idaho (PERSI) benefits in the same amount afforded to City of Stanley full-time employees.

Section 3: Chapter 2.06 is hereby repealed in its entirety.

Section 4: Chapter 2.06 is hereby adopted.

2.06.010: **MAYOR'S COMPENSATION**


- A. Commencing January 1, 2022, the Mayor shall receive an annual salary in the sum of sixteen thousand dollars (\$16,000), to be paid in monthly installments. The mayor shall receive Idaho Public Employee Retirement System of Idaho (PERSI) benefits in the same amount afforded to City of Stanley full-time employees.

Section 5: Effective Date


This ordinance shall be effective beginning January 1, 2022, following its publication as provided by law.
