Amendment**

AN ORDINANCE OF THE CITY OF STANLEY, A MUNICIPAL CORPORATION OF IDAHO, AMENDING ORDINANCE NO. 210, THE APPROPRIATION ORDINANCE FOR THE FISCAL PERIOD OCTOBER 1, 2020, THROUGH SEPTEMBER 30, 2021; PROVIDING FOR AN INCREASE IN EXPEDITURES IN STREETS AND ROADS and in PARKS & RECREATION; WHICH INCREASE THE TOTAL FISCAL YEAR EXPENDITURES BY \$190,000.00; PROVIDING THAT THE REVENUE TO PAY FOR SAID INCREASES SHALL BE DERIVED FROM TRANSFERS, GRANTS AND PREVIOUSLY UNAPPROPRIATED CASH BALANCES; PROVIDING THAT ALL OTHER PORTIONS OF APPROPRIATION ORDINANCE NO. 210 NOT HEREIN AMENDED SHALL REMAIN IN FULL FORCE AND EFFECT; PROVIDING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW, THE RULE REQUIRING THAT AN ORDINANCE BE READ ON THREE SEPARATE OCCASIONS HAVING BEEN DISPENSED WITH.

WHEREAS, after the Fiscal Year 2021 Appropriations Ordinance was passed and approved, additional revenues, including option taxes, have been received or will be received which will require additional appropriations: and

WHEREAS, due to an increase in bid projections for a scheduled storm drain and the Wall Street project and due to additional park grant expenses the city council decided to increase the expenses on these two-line items.

WHEREAS, an amendment to the FY 2021 appropriation ordinance is required to reflect the increased revenue and expenditures for the above-mentioned purposes; and

WHEREAS, notice and hearing have been provided in accordance with Idaho Code 50-1002 and 50-1003;

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STANLEY AS FOLLOWS:

SECTION 1: That the appropriations and the amount appropriated for the Streets and Roads and Parks and Recreation, and the resultant expenditures as set out in Section 1 of Ordinance No. 210, be hereby amended to reflect increased expenditures to be covered by additional revenues and/or option tax receipts:

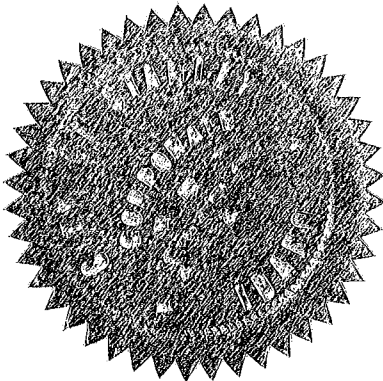
