ORDINANCE NO. 194

AMENDING ORDINANCE NO. 193, THE APPROPRIATION ORDINANCE FOR THE FISCAL PERIOD OCTOBER 1, 2014, THROUGH SEPTEMBER 30, 2015; PROVIDING FOR AN INCREASE IN EXPEDITURES IN THE GENERAL FUND, PARK FUND AND COMMUNITY BUILDING FUND; WHICH INCREASE THE TOTAL FISCAL YEAR EXPENDITURES BY \$54,812; PROVIDING THAT THE REVENUE TO PAY FOR SAID INCREASES SHALL BE DERIVED FROM TRANSFERS, GRANTS AND PREVIOUSLY UNAPPROPRIATED CASH BALANCES; PROVIDING THAT ALL OTHER PORTIONS OF APPROPRIATION ORDINANCE NO. 193 NOT HEREIN AMENDED SHALL REMAIN IN FULL FORCE AND EFFECT; PROVIDING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW, THE RULE REQUIRING THAT AN ORDINANCE BE READ ON THREE SEPARATE OCCASIONS HAVING BEEN DISPENSED WITH.

WHEREAS, after the Fiscal Year 2015 Appropriations Ordinance was passed and approved, additional revenues, including option taxes, have been received or will be received which will require additional appropriations; and

WHEREAS, the council has also decided to proceed with selected construction projects this year instead of future fiscal years, decided to pay cash for selected equipment instead of assuming debt and approved certain other additional expenditures to account for unanticipated events; and

WHEREAS, an amendment to the FY 2015 appropriation ordinance is required to reflect the increased revenue and expenditures for the above mentioned purposes; and

WHEREAS, notice and hearing have been provided in accordance with Idaho Code 50-1002, 50-1003, and 50-1006;

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STANLEY AS FOLLOWS:

SECTION 1: That the appropriations and the amount appropriated for the Park Fund, and Community Building Fund, and the resultant expenditures as set out in Section 1 of Ordinance No. 193, be hereby amended to reflect increased expenditures to be derived from additional revenues and/or tax receipts:


SECTION 2: That all other portions of the FY 2015 Appropriation Ordinance (No. 193) not herein amended shall remain in full force and effect.
