

ORDINANCE #195
Fiscal Year 2015-16

AN ORDINANCE OF THE CITY OF STANLEY, CUSTER COUNTY, IDAHO, A MUNICIPAL CORPORATION OF THE STATE OF IDAHO, ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2015, APPROPRIATING \$715,408 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF STANLEY, IDAHO, SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY, PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES, DIRECTING THE CITY CLERK TO FILE CERTIFIED COPIES OF THIS ORDINANCE WITH THE CUSTER COUNTY COMMISSIONERS AND IDAHO SECRETARY OF STATE, AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Mayor and Council of the City of Stanley, Custer County, Idaho:

Section 1: That the sum of \$715,408 is hereby appropriated to defray the necessary and proper expenses and liabilities of the City of Stanley, Custer County, Idaho, for the fiscal year beginning October 1, 2015.

Section 2: The following sums are hereby appropriated and allocated for the purpose of defraying expenses and liabilities for the following objects and purposes:

Section 3: That a general tax levy of \$71,224 on all taxable property within the City of Stanley be levied for the general purposes of said City, for the fiscal year beginning October 1, 2014.


Section 4: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.


Passed under suspension of rules by roll call vote at a convened meeting of the Stanley City Council held on the 13th day of August, 2015.
