Temporary RV employee housing requests w/Sewer hookup:

1. Mountain Village – 135 Sulfur Flats Loop. Councilmember Clegg moves to approve housing trailer with sewer hook-up. Council President Gadwa seconds. All approve. Motion passes.

Discuss possible action on Ace of Diamonds noise decibel level: Custer County will not respond to noise disturbance calls. The City Council instructed the mayor to write a letter to any business owner with music reminding them of the current noise ordinance.

Consider negotiating an MOU with Stanley Chamber of Commerce to create jointly funded assistant to the Mayor/Chamber Office Manager position: Councilmember Clegg moves to have the mayor negotiate and create an MOU with the Chamber of Commerce for a shared employee. Councilmember Cardoso seconds. All approve. Motion passes.

Discuss possible ordinance Revision 17.46 (RV Trailers) and Resolution #2021-7. Is this resolution adequate for the fee schedule under ordinance 17.46 or should a new resolution be created: The flat \$50.00 fee for violators that do not obtain a permit or park illegally, is not effective. The City Council discussed possibly charging the initial \$50.00 fee, the violator would then have 7 days to correct violation, if not corrected there could possibly be a daily or weekly fee. A new resolution would be created once the ordinance revision has been completed.


