Councilmember Cron seconds. Council President Gadwa reads by title only. Roll Call Vote: Council President Gadwa - Aye. Councilmember Clegg – Aye. Councilmember Cron - Aye. Councilmember Sentz- Aye. All approve. Ordinance #56 D-6 passes and is ready to be voted on November 3, 2020.

Roll Call Vote: Council President Gadwa - Aye. Councilmember Clegg – Aye. Councilmember Cron - Aye. Councilmember Sentz- Aye. All approve. Resolution #2020-05 passes.
