## **NEW BUISNESS:**

Ordinance #215 Appropriation Ordinance for FY21-2022: Council President Gadwa moves to approve Ordinance #214 and to suspend the rules and read by title only, one time only as per Idaho Code 50-902. Councilmember Clegg seconds. Mayor Botti reads by title only.

Roll Call Vote: Council President Gadwa - Aye. Councilmember Clegg - Aye. Councilmember Cron - Aye. Councilmember Cardoso - Aye. All approve. Ordinance #215 passes

Resolution #2021-10 to re-reserve Forgone Tax of \$703.00 subject to our Option Tax ordinance requirements: The City Clerk explained that the \$703.00 will always remain as a foregone amount as long as we have an option tax ordinance. In 2013 we went over our budget for option tax in the amount of \$113.00 and in 2014 \$590.00, the foregone amount was accidently taken last year and is now being put back as a foregone amount. Council President Gadwa moves to approve resolution 2021-10 re-reserving Forgone Tax amount of \$703.00. Councilmember Cardoso seconds. All approve. Motion passes.

Resolution #2021-11 Building Permit and Tiny House Park Fees: Council President Gadwa moves to approve resolution 2021-11 building permit and tiny house park fees. Councilmember Cardoso seconds. All approve. Motion passes.

Greg Wallace is requesting earned vacation time of 43.0 hours to be moved to fiscal year 21-2022: Council President Gadwa moves to approve Wallace's request of 43.0 hours to be moved to FY21-2022. Councilmember Clegg seconds. All approve. Motion passes.
