The work session is called to order at 1:19 on Monday, October 13, 2014 in the Stanley City Office.

**IN ATTENDANCE FOR THE CITY:**

**STANLEY CURLING CLUB:**

Proposed curling sheet in Pioneer Park. Doug Plass has submitted a map per the request of the Council on 10-9-2014. The curling lane will be 20' by 146'. The requested location will be west of the groomer shed running slightly diagonally from southwest to northeast. This location is preferred due to this patch being reasonably level ground and close to the water supply. Councilmember Gadwa makes a motion that we approve the curling lane as presented with the understanding it is temporary in nature and that as the Master Plan develops and is constructed the curling sheet may have to be moved, and that no expense of the curling sheet will come back to the City of Stanley. Councilmember Sentz seconds. All approve. Motion passes.

**SIGN PERMIT#1409171:**

Sawtooth Traxx needs to resubmit the permit request per the Council Meeting on 10-9-2014. They were unable to resubmit permit in time for this meeting. City Council would like the sign taken down until the request is reissued for the City Councils approval.

**CODE VIOLATION PENALTIES:**

The City Clerk emailed out a draft of the most recent list of code penalties to a group called code review asking for their comments or concerns. We only received one comment back, regarding construction of homes not being completed within a certain time limit.

The Council went through all 37 line items and discussed in length which code references needed to be changed and which code references needed to stay the same. Some of the highlights were: possibly removing the open container penalties, temporary vendors and business license reduced to an infraction, outdoor burning permit needed for larger fires, dangerous weapons needing a permit, disturbing the peace changing to an infraction, public sewer-failure to connect changing to an infraction, and zoning-recreation vehicles when a permit is required.

All of these changes will be presented to our attorney for review, once approved, then we will have a public hearing to finalize changes.
