IN ATTENDANCE FOR THE CITY:

Mayor Steve Botti, Councilmember Austin Clegg, Councilmember Tim Cron, and Council President Laurii Gadwa. All answered to roll call. Councilmember Gabriel Cardoso Arrived at 5:15 p.m. and left at 5:50 p.m. City staff members included: City Clerk/Treasurer Cari Tassano and Kimberly Peters in maintenance.

CALL TO ORDER:

The meeting was called to order by Mayor Botti at 5:05 p.m.

AGENDA AMENDMENTS:

MAYOR COMMENTS:

Stanley to Redfish Lake Trail is 99% complete. Early spring 2023 it will be officially opened.

COUNCIL COMMENTS:

CITIZEN PARTICIPATION:

Jeff Welker will be organizing the Bike Fundo as a separate event and it will not be part of the Winterfest Event, although it will be occurring on the same weekend. 100% of the profits will be given to the groomer fund with the City of Stanley. He will be requesting a donation from the City of Stanley (in a later meeting) for the expense of T-Shirts for the event.

CONSENT AGENDA:

10-13-22 Council Meeting, 10-21-22 Special Meeting and the payment approval report – unpaid and prepaid bill for October/November. Council President Gadwa moves to approve Council Meeting Minute 10-13-2022 and the unpaid the prepaid bill for October/November. Councilmember Clegg seconds. All approve. Motion passes. Council President Gadwa feels the 10-21-22 Special Meeting were not depicted correctly and will be submitting a redline correction for review. Gadwa did not supply a correction in this meeting, nor did she state what the corrections will be.

LAW ENFORCEMENT:

We did not receive a basic report for October 2022, and we are still not receiving detailed reports as per our Law Enforcement Agreement with Custer County. The last detailed report was in April 2022.

COMMUNITY BUILDING:

A sculpture was placed in front of the City of Stanley, it was originally at the Stanley Town Square. Tab Stuart is the artist that built the sculpture and he was pleased it was able to remain in Stanley.

PIONEER PARK:

STREET AND ROADS:

The Winter Streets and Road contract is completed. Very little snow so far.

AD HOC COMMITTEES:

Cemetery: none

Code Review: hoping to have an omnibus ordinance to review soon.

Sawtooth Interpretive & Historical Association: none

Snowmobile Groomer: Groomer is back. We need 18" of snow before we can start grooming. There is not enough snow to start grooming the Park Creek Trail.

Chamber of Commerce: There is an Idaho Snow Show in Boise that the chamber will be attending. Bingo night will be the 14th of December. We will be interviewing potential (shared) employees for the Chamber and the City.

OLD BUSINESS:

Discuss options for the Public Water System on the 4-Acres: Mayor Botti explained that we need to set-up a well driller for the production well, prior to knowing if we will be awarded a gem grant in December/January. If we don't arrange for the well driller now, we could lose a whole year. All councilmembers agreed that this was a good idea.

NEW BUSINESS:

Right of Entry Agreement with Sawtooth Valley Builders expiring 11/20/22 – Storage of equipment and materials on 4-acres by the museum: It was proposed that the area is only needed for a couple extra months and requested that the contract move to a month-to-month basis with no end date. It was brought to Tim Cron's attention that trailers and boats were being stored on the property, as he understood it this area was storage of building material only. Council President Gadwa moves to approve the new agreement on a month-to-month basis with no end date. Councilmember Cardoso seconds. Councilmember Cron is opposed. Motion passes.

Memorandum of Understanding by Jane Somerville for the Community Library Story Walk project: Due to lack of information provided in the one sentence memorandum, it was necessary to add key factors to the memorandum i.e., installation requirements, financial responsibilities, park protocols, etc. Councilmember Gadwa moves to table memorandum of understanding until a fully incorporated memorandum can be completed by the city. Councilmember Clegg seconds. All approve. Motion passes.

14th annual Stanley Winterfest February 17-18, permissions and request by the Stanley Chamber of Commerce and donation request of \$500.00 Alpine Peak Level: Councilmember Clegg moves to approve. Council President Gadwa seconds. All approve. Motion passes.


CITY CLERK REPORT:
