**BUILDING PERMIT/APPROVED ADMINSTRATIVELY:** Building Permit #966 - Hughes, Jerry - 257 Wall Street, New Construction was approved by Greg Wallace on 8/16/2021.

**BUILDING PERMITS/CITY COUNCIL APPROVAL:** Building Permit #967 Clark, Neil – Tract 467 Stanley Annex – Grading Permit. Building Permit #922 was issued on June 13, 2019, for storage of fill. Council President Gadwa moves to approve for grading only. With the condition it does not impede with the wetlands or floodplain. Councilmember Clegg seconds. All approve. Motion passes.

Mayor Botti explained that even though this permit does not need to be evaluated by the City Floodplain administrator. A future building permit will need to be evaluated.


**CITY CLERK REPORT:** The City Clerk reported to the City Council item she has been working on:


