

## City of Stanley Work Session/Omnibus Ordinance August 27, 2015

The work session is called to order at 4:38 p.m. on Thursday, August 27, 2015 in the Stanley City Office.

### **IN ATTENDANCE:**

Mayor Herb Mumford, Councilmember Laurii Gadwa, Councilmember Lem Sentz, Council President Steve Botti, maintenance personal Greg Wallace and City Clerk Cari Tassano. Councilmember Hadzor has tendered her resignation as of August 25<sup>th</sup> and is no longer on the City Council.

### **MEETING CORRECTION:**

We are having this meeting as a violation cure of open meeting law pursuant to Idaho code 74-208 (7) (a) (I) (B-D), declaring the prior meeting on August 17, 2015 void and moving forward with the open meeting law.

### **OMNIBUS ORDINANCE:**

We are having this meeting to complete the Omnibus Ordinance, which is changing many code violations.

Allison Beechert is concerned with Section 13, 08.14.020 and the possibility of people living out of their vehicle. The group discussed the possibilities of people sleeping in their vehicles would not be covered in the current code; the discussion moved to what would be the best way to word this within section 08.14.020. It was decided to add the wording all camping, "including sleeping in vehicles".

Councilmember Gadwa notes that we have two ordinances. The first one is definitions for an infraction or for a misdemeanor prepared by our attorney. The second one is the draft we have been working with that shows the ordinance violations.

Section 15, 09.04.020, disturbing the peace, this is redundant, already in Idaho code and is hereby deleted from the City code.

Section 16, 09.04.040, disturbing the peace violation penalty, the first half of the paragraph will be deleted and the new paragraph will start with: "any person causing excessive noise under 09.04.03 for a first and second offense within a five year time period shall be deemed guilty of an infraction punishable as provided in section 1.08.020. A third subsequent convictions within a five year time period shall be deemed a misdemeanor punishable as proved in section 1.08.010".

Section 19, 12.04.020, Airport Property Restrictions. It was decided to add wording to the end of the paragraph that says: "the owner and/or pilot and passengers of an aircraft can camp in the immediate vicinity of the aircraft provided they can present documentation of ownership or a valid pilot's license and are located where they will

not impede the operation of any other aircraft". This is common language for back country strips and rural airports.

Page 2 Amending Title 9, (the first paragraph) shall now read: "Public peace, morals, and welfare, Chapter 09.04 disturbing the peace; noise, section 09.04.020 disturbing the peace; deleting section 09.04.020 and amending the penalty provision in section 09.04.040".

Section 12.04.060 will remain the same and there will be no changes. It does not conflict with Idaho code.

Councilmember Gadwa makes a motion to approve both ordinances and to schedule the public hearing for both ordinances. Council President Botti seconds. All approve. Motion passes.

**EXECUTIVE SESSION:**

Councilmember Gadwa makes a motion to go into Executive Session as per Idaho Code 74-206 (1) (d) (f) at 5:04 p.m. Council President Botti seconds. Roll call vote was taken by the City Clerk: Council President Botti – Aye; Councilmember Gadwa – Aye; and Councilmember Sentz – Aye. All approve. Motion passes.

Councilmember Gadwa makes a motion to adjourn executive session and go into regular session at 5:20 p.m. Council President Botti seconds. Roll call vote: Council President Botti – Aye; Councilmember Gadwa – Aye; and Councilmember Sentz – Aye.

**REGULAR SESSION:**


