Regular Council Meeting Minutes  
July 10, 2014**

**CALL TO ORDER:**

The meeting is called to Order by Mayor Mumford at 6:03 p.m.

**MAYORAL COMMENTS:**

Mayor Mumford comments there are a lot of people in town; we had a good turnout on the 4<sup>th</sup> of July. Mayor Mumford pointed out we need to be kept notified on any changes of the upcoming Street Dances throughout the summer months.

Mayor Mumford also points out that there is an ongoing trash issue here in town. The Forest Service has removed their trash dumpster from the parking lot on hwy 75 that was in place for tourist and not for use by the community of Stanley (this lot is also referred to as the K-Mart parking lot). They removed the dumpster because of the growing use by the community. The Mountain Village has experienced the same problem with their dumpster. The City of Stanley is also experiencing similar problems, the City does not provide trash services for the community or the public (only for renters of the community room and park), it is not in our budget to do so, and therefore, it was decided to lock our dumpster.

**CITIZEN PARTICIPATION:**

John Phillips spoke regarding the speed trenches; Mr. Phillips thinks we need an additional one at the top of Wall Street. People are traveling way to fast coming off the top of the hill. He discussed the handicap parking at the community building. The Council pointed out that there is handicap parking in the front of the building on Hwy 21.

Council President Botti commented that John Hess the general manager of Boise State Public Radio will be having a meeting to discuss the future of Public Radio on Wednesday, July 16, 2014 at the library from 6:00 to 8:00 p.m. This is specifically for rural Idaho.


There were no Building Permits for the City Council to approve.


**CITY CLERK REPORT:** (City Clerk/Treasurer Cari Tassano)


**ADJOURNMENT:**

# APPROVED

## PROCLAMATION

**WHEREAS**, on September 3, 1964, President Lyndon Baines Johnson signed the Wilderness Act into law, creating America's National Wilderness Preservation System; and

**WHEREAS**, America's wilderness landscapes provide opportunities to discover and explore places that inspire awe, wonder and delight while providing natural habitats for diverse wildlife; and

**WHEREAS**, the National Wilderness Preservation System helps secure and preserve the enduring resource of wilderness for present and future generations; and

**WHEREAS**, the City of Stanley and its residents and visitors have been blessed by the extraordinary environment and beauty of nearby wilderness areas, the Sawtooth Wilderness and the Frank Church River of No Return Wilderness; and

**WHEREAS**, the attraction of Wilderness for visitors and residents alike helps bring some business to our community which is essential for our economic well-being.

**NOW, THEREFORE**, be it resolved that I, Herbert Mumford, Mayor of the City of Stanley do hereby proclaim September 2014 as

**WILDERNESS APPRECIATION MONTH** in the City of Stanley, and encourage all citizens of Stanley to join me in celebrating 50 Years of the Wilderness Act and in appreciating the ways that the protected wilderness areas surrounding our community enhance our way of life.
